What information we collect, use, and why

Grants for organisations and churches:

- Personal data: names, contact details and correspondence
- Special category data: Access needs (for events or Access Bursaries)

Individual grant enquiries:

- Personal data: names, contact details and correspondence (for signposting)
- Anonymised data: information about financial needs and borough of residence

Individual grant-monitoring (pseudonymised):

- Personal data: gender, information about financial needs, housing, household type, age, partial postcode, case reference, case studies
- Special category data: Health information, Racial or ethnic origin, Sexual orientation

Professional contacts:

Personal data: names, contact details and correspondence

Property management:

- Personal data: Names, contact details, correspondence, addresses, records of meetings, financial information.
- Special category data: Health information (when necessary for protected tenants)

Recruitment:

- Personal data:
 - Names, contact details and correspondence
 - o Employment history (e.g. CV and job application)
 - Employment references (confidential)
- Special category data: Recruitment Monitoring Form (unnamed/pseudonymised)

Lawful bases and data protection rights

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the Information Commissioner's Office's (ICO) website.

Which lawful basis we rely on may affect your data protection rights which are in brief set out below. You can find out more about your data protection rights and the exemptions which may apply on the ICO's website:

- Your right of access You have the right to ask us for copies of your personal
 information. You can request other information such as details about where we get
 personal information from and who we share personal information with. There are
 some exemptions which means you may not receive all the information you ask for.

- Your right to rectification You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete. You can read more about this right here.
- Your right to erasure You have the right to ask us to delete your personal information. You can read more about this right here.
- Your right to restriction of processing You have the right to ask us to limit how we can use your personal information. You can read more about this right here.
- Your right to object to processing You have the right to object to the processing of your personal data. You can read more about this right here.
- Your right to data portability You have the right to ask that we transfer the personal information you gave us to another organisation, or to you. <u>You can read more about this right here</u>.
- Your right to withdraw consent When we use consent as our lawful basis you have the right to withdraw your consent at any time. You can read more about this right here.

If you make a request, we must respond to you without undue delay and in any event within one month.

Our lawful bases for the collection and use of your data

Grants for organisations and churches:

- Contract we have to collect or use the information so we can enter into a grant agreement with you. All of your data protection rights may apply except the right to object.
- Consent (for special category data or for sharing data) we have permission from you after giving you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

Individual grant enquiries:

• Contract – we have to collect or use the information so our Partner organisations can enter into a grant agreement with you. All of your data protection rights may apply except the right to object.

Individual grant monitoring:

 Consent (devolved to Partner organisations) - Partner organisations have permission from you after giving you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

Property management:

 Contract – we have to collect or use the information so we can enter into or carry out a contract with you. All of your data protection rights may apply except the right to object.

Recruitment:

Contract – we have to collect or use the information so we can enter into or carry
out an employment contract with you. All of your data protection rights may apply
except the right to object.

Where we get personal information from

- Directly from you
- Partner charities (individual grants monitoring)
- Property managers and lawyers
- Churches

Who we share information with

We have a joint controller relationship with Cripplegate Foundation. We process personal information with that joint controller only in relation to Catalyst grants, for the joint monitoring of that programme.

Others we share personal information with:

- Professional consultant Centre for Accessible Environments (Church Access Project)
- Professional consultant Inspired Efficiency (Sustainable Church Buildings Project)
- Property managers and lawyers (landlord duties)
- IT systems and IT support providers (data processors)
